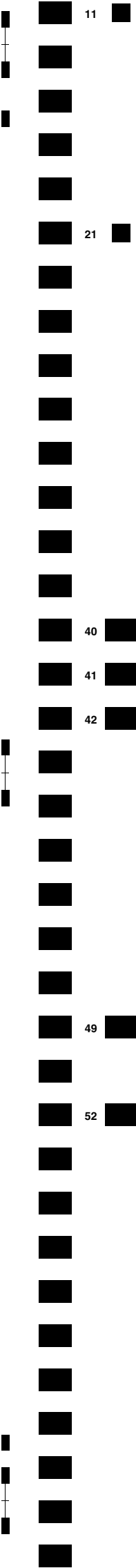

<p align="center">INSTRUCTIONS TO VOTER</p> <p>1. TO VOTE YOU MUST BLACKEN THE OVAL (●) TO THE LEFT OF YOUR CHOICE COMPLETELY. An oval (●) blackened to the left of the name of any candidate indicates a vote for that candidate.</p> <p>2. To vote a straight party ticket, darken the oval to the left of the party of your choice. To vote for an individual candidate of another party after darkening the oval of your party choice, darken the oval to the left of his/her name. For an office where more than one candidate is to be voted for, the voter after darkening the oval in the party column, may divide his/her vote by darkening the oval to the left of each candidate for whom he/she desires to vote. For such office votes shall not be counted for candidates not individually darkened.</p> <p>3. To cast a write-in vote for a person whose name is not on the ballot, you must blacken the oval to the left of the line provided, and write, print or paste the name in the blank space provided for that purpose.</p> <p>4. If you make a mistake DO NOT ERASE. Ask for a new ballot.</p> <p>5.
